

# **Memorandum of Understanding**

Between

**Iraqi Inventors & Innovators Society**

and

**Al-Kitab University**

This Memorandum of Understanding (MOU) sets for the terms and understanding between the **Society** and the **University** to Intellectual Property and commercialization services.

## **Purpose**

According to this MOU, the **Society** and the **University** are expected to provide the following services to applicants:

1. Consultation on the National and International Strategy for the Protection of Intellectual Property;
2. Compilation of patent documents (according to international standards);
3. Patent application in patent Cooperation Treaty (PCT);
4. Organizing relevant courses and workshops nationally and internationally;
5. Providing intellectual property legal claims;
6. Providing commercialization services nationally and internationally.

## **Goals:**

- 1- Establishing Al-kitab Intellectual Property Services Center which aims to:
  - Take care of Iraqi inventors and innovators and provide them with opportunities to support their creative work in various scientific and cultural fields.
  - Develop cooperation with governmental departments local and international organizations specialized in the protection of intellectual property rights.
  - Establish of scientific and cultural meetings such as conferences, seminars and specialized workshops inside and outside Iraq that deal with intellectual property issues to activate the Iraqi laws concerned with the protection of intellectual property.
  - Provide scientific and legal references on intellectual property issues (documentary research).
  - Publish a periodical journal specialized in publishing creative researches in all specialties.
2. The accession of the Al-kitab Iraqi Transfer Technology Center to the membership of the World Intellectual Property Organization.

## **Costs**

The Costs of services will be announced in case of requests.

## **Duration**

This MOU shall become effective upon signature by the authorized officials and will remain in effect until modified or terminated by any one of the two partners by mutual consent.
